

Chiara Cordelli is Professor of Political Science at the University of Chicago. Her main areas of research are social and political philosophy, with a particular focus on theories of distributive justice, political legitimacy, normative defenses of the state, and the public/private distinction in liberal theory. Beyond several articles, she is the author of *The Privatized State* (Princeton University Press, 2020), which was awarded the 2021 ECPR Political Theory Prize for best first book in political theory, and of *Privatocrazia* (Mondadori 2022), as well as the editor of *NOMOS* and the co-editor of *Philanthropy in Democratic Societies* (University of Chicago Press, 2016). Professor Cordelli has held visiting positions at Stanford, Princeton, Harvard and at the *École des hautes études en sciences sociales*.

Mariano Croce is Associate Professor of Political Philosophy at Sapienza University of Rome. He is also Research leader of the research group in Kinship Studies at the Faculty of Law of the University of Antwerp, Belgium. His books include *Carl Schmitt's Institutional Theory* (Cambridge University Press, 2022, with Andrea Salvatore), *The Legacy of Pluralism: The Continental Jurisprudence of Santi Romano, Carl Schmitt, and Costantino Mortati* (Stanford University Press, 2020, with Marco Goldoni), and *The Politics of Juridification* (Routledge, 2018). He has edited and translated into Italian some key works by Carl Schmitt, Karl Loewenstein, and Karl N. Llewellyn, and has edited and translated into English two key books by Santi Romano.

Greta Favara is a lecturer (Rtd-a) in political philosophy at Vita-Salute San Raffaele University, where she teaches political philosophy and the theory of global justice. Previously, she was a research fellow at the school of social sciences at New York University (Shanghai campus). Her research interests revolve around the methodology of political theory, with particular attention to the relationship between ideal and non-ideal theory, political liberalism, and the feasibility issue. Her latest book is *Prendere la politica sul serio: il realismo nella filosofia politica contemporanea* (AlboVersorio, 2023).

Alessandro Ferrara is Professor Emeritus of Political Philosophy at the University of Rome Tor Vergata and Adjunct Professor of Legal Theory at LUISS Guido Carli University. Recently he has published *Sovereignty Across Generations. Constituent Power and Political Liberalism* (Oxford University Press, 2023), awarded the “Best 2023 Book” Prize by ICON-S, International Society of Public Law and, together with Frank Michelman, *Legitimation by Constitution: A Dialogue on Political Liberalism* (Oxford University Press, 2021). He also authored *The Democratic Horizon: Hyperpluralism and the Renewal of Political Liberalism* (Cambridge University Press, 2014).

Anna Elisabetta Galeotti is Full Professor of Political Philosophy at the University of Eastern Piedmont, Vercelli. Her research interests range from toleration, multiculturalism, equal respect to deception, self-deception and distorted communication in politics. Among her English publications: *Toleration as Recognition* (Cambridge University Press, 2002), “Autonomy and Cultural Practices: The Risk of Double Standards”, *European Journal of Political Theory* (2015), “The Range of Toleration”, *Philosophy and Social Criticism* (2015), “Cultural Conflicts: A Deflationary Approach”, *Critical Review of International Social and Political Philosophy* (2017), *Political Self-Deception* (Cambridge University Press, 2018), “Rescuing Toleration”, *Critical Review of International Social and Political Philosophy* (2019, with Federica Liveriero), “Toleration between Liberty and Security”, *Journal of Ethics* (2021, with C. Meini), “Scientific Disinformation and Fake News: A Blurred Boundary”, *Social Epistemology* (2022).

Elena Icardi is a post-doctoral researcher at the Centre for Ethics, Politics and Society (CEPS) of the University of Minho. Prior to joining CEPS, she was a research fellow at the University of Pavia. She holds a Ph.D. in Polit-

ical Studies from the Network for the Advancement of Social and Political Studies (NASP) of the University of Milan (Political Theory curriculum), with a thesis on “Freedom as Non-Domination and Equality: A Neo-Republican Theory of Distributive Justice”. During her Ph.D. she also spent a visiting period at the Ethics Institute of Utrecht University. Her research interests include freedom as non-domination, political equality, and distributive justice. She recently contributed to Robeyns's book *Having Too Much: Philosophical Essays on Limitarianism* (Open Book Publisher) with a chapter entitled “A Neo-Republican Argument for Limitarianism”. For *Biblioteca della Libertà* she published “Perché limitare l'eccessiva ricchezza individuale? Ragioni e problemi del limitarianesimo” (vol. LVII, 2022).

Pietro Maffettone is Associate Professor of Political Philosophy in the Political Science Department at University of Napoli Federico II. Before joining the University of Napoli he received his PhD from the LSE and was Lecturer in Global Politics and Ethics at Durham University. His research interests are in international ethics, and the relationship between ethics and economics.

Francesca Pasquali is Associate Professor of Political Philosophy at the University of Milan. Her research interests include methodological issues in political philosophy, with a particular focus on the comparison between ideal and realist approaches, the relationship between facts and principles, and the connection between normative and empirical approaches to politics. Additionally, she works on normative theories of democracy and democratization processes, on hybrid and authoritarian regimes, and on the promotion of democracy.

Federico Gustavo Pizzetti is Full Professor of Public Law, University of Milan, Department of International, Legal and Historical-Political Studies. Born in 1976, graduated in Law at the University of Turin (Italy) in 1999, Federico G. Pizzetti has been Full Professor of Public Law at the University of Milan (Italy), since 2015. He has written more than 150 publications (among which, 8 books), and has been invited or selected speaker to more than 40 International conferences. He is a member of the International Forum of Teachers in Bioethics, medical ethics and medical law, UNESCO Chair in Bioethics; of the European Association of Health Law; of the Italian Society of Neuroethics and Philosophy of the Neurosciences (currently, also Presi-

dent); of the Italian Association of Constitutional Lawyers. He is also affiliated of the Initiative on Neuroscience and the Law Project, Houston Baylor College of Medicine. He has been principal investigator of local units in Italian PNRR-NGEU Project (SERICS), and in Italian PRIN Project (ELVIS). His research areas are about the End-of-Life Decision-making Law, the Constitutional Law and Neurosciences, the Duties to protect vulnerable persons (in particular, against infodemic).

Roberta Sala is Full Professor of Political Philosophy at Vita-Salute San Raffaele University, where she teaches courses in political philosophy, public ethics, political legitimacy and democratic theory. She is Director of CeSEP (Centre for Studies in Ethics and Politics) and President of the Undergraduate Programme of the Faculty of Philosophy. Her research interests focus on normative political theory, public ethics and bioethics. She is the author of several books and articles, including *Il silenzio di Dio: religione, credenze, rispetto* (Edizioni Sanpaolo, 2014) and *Filosofia per i professionisti della cura* (Carocci, 2014).

Marco Santambrogio has taught Philosophy of Language at the University of Parma and San Raffaele University in Milan. He is a founding member of the European Society for Analytic Philosophy (ESAP) and the Società Italiana di Filosofia Analitica (SIFA). He has written numerous contributions for Italian and international scientific journals. His publications include: *Chi ha paura del numero chiuso?* (1997), *Manuale di scrittura (non creativa)* (2006), *Il complotto contro il merito* (2021), *Filosofia e storia* (2004).
